Venue Rental Contract

- Venue Rental refers to the use of the Gathering Place on Main dining room, rest rooms, chairs and tables, bar area, light use of kitchen (not for caterers to make food), outdoor sitting area. Rentals include clean up and on street parking.
- 2. Deposit - Rentals require a \$75 deposit. The balance is due 14 days prior to the rental. If the balance is unpaid by that time the rental is cancelled and the deposit forfeited. If renter wishes to cancel a date, 30 days notice shall be given or deposit will be forfeited. If the venue was left on time, no damage occurs, and all the rental conditions are met the deposit will be refunded by the next day of rented space.
- Returned Checks There will be a \$40.00 charge on all returned checks.
- Payment All payments must be made by cash, check, money order, Venmo or Paypal and made out to Gathering Place on Main.
- Maximum occupancy is not to exceed 50 people. Seats 48
- Renters shall make no modifications to the hall except for arrangements of tables & chairs.
- No thumbtacks, nails, tape or decorations shall be attached to walls or ceiling. In addition, there will be no glitter or confetti defacing of structure or contents in any way. Doing so will result in the loss of deposit, plus reimbursement for damages
- Renter is responsible for any damage to building, fixtures, contents of building, and/or any supplies or merchandise removed/missing from 8. the hall. Damage or loss of property will result in loss of deposit and any excess of the deposit billed to renter.
- Gathering Place on Main is neither responsible nor liable for damages, personal injuries and lost or stolen articles.
- Renter agrees to pay for all damages excess charges within 30 days of the rental.
- Any alcoholic beverages served will be the sole responsibility of the renting party. Gathering Place on Main assumes no liability or responsibility for injury, death, or damage that results from the renting party providing or consuming alcohol. A Liquor License from New York State is required for all fundraisers serving and/or selling alcohol. MUST SHOW PROOF OF LICENSE OR INSURANCE PRIOR TO
- 12. Rental /Cleanup Times Morning slot rentals on Friday/Saturday/Sunday must vacate premises by 2 pm. Evening slot must vacate by 10 pm. Monday thru Thursday hourly Rentals must vacate premises within 10 minutes after the rented time slot.

 All parking signs shall be obeyed. NO PARKING SHALL BE ALLOWED IN BACK PARKING LOT OF BUILDING. On street parking only.
- No one is allowed on the roof or any other areas not for public use.
- 15. There is NO SMOKING at any time, inside venue building. Any smoking, by anyone at any time, in the venue will result in total loss of the deposit.
- 16. Venue opens at 8 am and guests must vacate building at 10 pm.
